Introduction

Welcome to the 2016.1.9 release of MYOB Advanced.

What's New in this Release?

The 2016.1.9 release introduces addresses issues across the MYOB Advanced system. The following sections provide details of the changes included in this release.

Installing this Release

The 2016.1.9 release is automatically deployed to all production accounts.

Note: An updated licence is required to enable configuration options for the new features. While accounts in our managed environment will have their licences updated automatically, a local installation must be updated manually by navigating to the Licence Maintenance (SM.20.15.10) form and clicking the **Update Licence** button.

New Features

Payroll Tax Code Changes

This release includes changes to the taxation options for pay items in the Payroll module of Advanced People. These options can be seen in the **Taxation** dropdown on the Pay Items form (MP.PP.22.10).

Australian Tax Codes

New taxation options relating to employee terminations are available for Australian companies. (Termination features will be added in an upcoming release—for now, these options should not be used.)

NZ Tax Codes

For NZ companies, all Extra Pay taxation options have been consolidated into a single "Taxable : Extra Pay" option.

When viewing an Extra Pay pay item on the Employee's Current Pay form (MP.PP.31.30), the **Extra Pay IRD Classification** dropdown in the footer now contains only two options:

- Extra Pay
- Elected custom rate
